The Buyer agrees to obtain from the seller a Pug.

This Pug comes from Buckingham Pugs in Arab, Alabama.

The seller certifies that upon receipt, the dog is in good health and has been immunized and wormed according to the accompanying health record of said Pug.

* I am aware Pugs are prone to snore, snort, wheeze, honk, have Stenotic Nares (small nostrils), have gas, and shed a lot. They're also prone to allergies, respiratory issues, especially if allowed to become overweight, skin problems, eye issues, luxating patella, umbilical or inguinal hernias, and have sensitive stomachs and sensitive skin. None of these "common" pug problems are covered in our health guarantee. _____

The buyer agrees to have the dog examined by your veterinarian at your expense within 3 weeks from the date of possession. The buyer agrees to email seller a copy of veterinary visit in order for the Health guarantee to remain in effect. If the veterinarian does not give the dog a clean bill of health, buyer must notify the seller immediately. Seller reserves the right to have the dog reexamined by a veterinarian of our choice at our expense. Any condition that is minor, correctable, or a breed related minor condition is not covered and any condition which will go away as the puppy gets older is not covered. We will not accept responsibility for any harm that comes to the dog once in your possession such as accidents, electrocution, heat related conditions or any other related actions. Seller does not accept responsibility for contagious diseases diagnosed after 3 weeks from the date of possession. In the event your Pug is diagnosed within one year of purchase with an untreatable genetic condition, we will replace the puppy with one from our next available litter. We will require documentation from your veterinarian, including copies of all tests and examinations and in the case of death a necropsy performed for our veterinarian to review. _____

*Although we make every attempt to prevent worms and other parasites there is always a chance they are picked up from environment and other animals (strays and wildlife track them everywhere) and are not covered in our guarantee. Our recommendation is dogs should continue monthly de-wormers for life. _____

This puppy has received its first vaccines and to avoid disease the buyer will need to follow up on them. Buyer must have the puppy seen by a licensed vet within 3 weeks of pickup date which is __/__/__ and send breeder a copy of the visit post marked no later than __/__/__ to be received by breeder via Emailing or texting a scan/copy of vet visit or health guarantee is void. Also acceptable is to send it through the U.S. Postal Service mail is, but it is buyer's responsibility to make sure it was received. If breeder is not able to print it out a copy must be sent via U.S. postal mail. _____

The Buyer's Responsibility

* I Will NOT make sudden or drastic food changes as it causes stress and lowers the immune system to a breed prone to many issues already. I will use the food breeder is using for at least the first week. Should I choose to change the diet I will wait until after the first week to transition and transition slowly taking a minimum of a week to do so. The puppies are currently eating **Wholesomes Puppy Chicken Meal and Rice Recipe Dry Dog Food**. _____

* I Will NOT expose puppy to public animal places (example: pet stores, dog parks, places people hike frequently with their dogs) until all vaccines (4 total) are completed around 16 weeks old. After vaccines are completed, I will socialize my puppy and expose them to new people and places as socialization is a process that must be continued throughout their lives.

*Buyer agrees NOT to vaccinate their Puppy before __/__/__. Vaccinating prior to this date has serious consequences, including seizures, brain swelling, decreased effectiveness of vaccinations, and death. _____

* I UNDERSTAND there are NO REFUNDS under any circumstances. I also understand I WAIVE ANY LEGAL RIGHT TO TAKE LEGAL ACTION AGAINST BREEDER for ANY REASON and all issues will be handled between breeder and Myself only. Should I have any problems I will contact the breeder. _____

*I will put "Buckinham Pugs" into my puppy's official AKC name as the first word "Buckingham Pugs...." to show that the puppy came from the Buckingham Pugs line of pugs. I understand Buckingham Pugs cannot be put anywhere in the middle or end of the name. _____

The buyer agrees to take good care of this dog, feed and house properly, maintain them up to date on shots. The dog's outdoor area shall be safe and secure for the dog and everyone else. If the dog is found to be allowed to run freely and hence creating a public nuisance or found to be neglected, abused or allowed to live in poor health or conditions the Seller has all rights to repossession of this dog with no refund to Buyer. The death, injury or loss of said dog due to theft, carelessness, recklessness, abuse, neglect, heat stroke or accident will not entitle the Buyer to any compensation from the Seller. _____

Seller shall not be liable to purchaser for any other claim, loss, damage or expense or emotional harm, incidental or consequential damages, whether caused directly or indirectly. Liability for any such damages is hereby expressly disclaimed.

Restrictions on Transfer. If, at any time, Buyer is unable to keep or care for the puppy/dog (including upon Buyer's death or incapacity), at Breeder's sole election, the puppy shall be (a) returned to Breeder together with duly executed documentation transferring Buyer's ownership interest in the puppy/dog to Breeder or (b) rehomed by Buyer with Breeder's prior written approval, in each case without any refunds or payments due to Buyer. Buyer is not acting as an agent in the purchase of the puppy/dog. Buyer agrees neither the puppy/dog, nor any offspring of the puppy/dog, shall be used for purposes of vivisection or research. Buyer also agrees neither the puppy/dog, nor any progeny of the puppy/dog, shall be sold by or through any commercial broker or wholesale establishment, any chain store, catalog sales house or pet store. Any changes to this contract must be in writing and signed by both parties. This contract is legal even if it is not notarized and may be enforced by legal means at the Buyer's expense and all disputes must be settled in Madison County in the state of Alabama. This dog is sold to you as a Pet only and nothing further.

This is the entire agreement (4 pages) between the parties and is valid and agreed to by all parties. All parties have read and understood and agreed to this contract in full by signing below. If parties chose to use electronic signatures, they are under the understanding that this is still a valid agreement.
